SPECIFICATIONS

DESCRIPTION:

Wood Cleaner is designed specifically to clean wood decks, fences and siding. It stops new wood from greying or darkening, and returns luster to old wood. **Wood Cleaner** refreshes wood damaged by sun exposure and water from rain and sprinklers. This cleaner will outperform any of its type, aggressively extracting mildew, mold, algae and tannin from most wood surfaces. Developed from a water based concentrate, it can be diluted with up to 5 parts water, making it highly cost effective. Dilution rate determines cleaning power.

USE:

Wood Cleaner can be used for any exterior, unpainted wood surface.

Wood Cleaner is ideal for use on:

- decks and fences
- siding and panelling
- trellises and latticework
- exterior awning frames
- exposed wood shutters

Product results will vary by substrate and application method. ***It is the user's responsibility to determine the suitability and performance of this product for their application.***

APPLICATION DATA

SURFACE PREPARATION:

- Before use, thoroughly test this product on a sample to assure performance and appearance.
- Always test on a small area to be sure cleaner is not removing or damaging surrounding surface coating or sealer.
- Water down surrounding plants, ground cover and grass to avoid temporary discoloration.
- Remove excess dirt and debris from surface to be cleaned.

APPLICATION:

- Shake thoroughly before mixing or using.
- **Always add solution to water, then stir or mix. Adding water to solution will result in foam and bubble formation.**
- Mix with up to 5 parts water and apply to surface with sprayer or other manual method. If not sure which dilution to use, start with a light solution and add cleaner until ideal results are met.
- Let stand 2 to 5 minutes; do not allow to dry.
- Scrub surface with a stiff brush or broom.
- Rinse thoroughly or until foaming stops.
- If cleaner dries on surface, reapply and continue.
- Allow surface to dry completely before applying sealers, coatings, or paint.

DO NOT MIX THIS PRODUCT WITH BLEACH

Wood Cleaner is incompatible with chlorine bleaches, ammonia, and most other cleaners. Do not use on metal.

Application Caution:

Cover all plants, trees, grasses, and shrubs to protect from overspray. If overspray occurs, wash off with water immediately. Mask areas that may be affected by overspray.

RECOMMENDED DILUTION RATES:

1:1 Heavily soiled, ground in dirt, deep seeded and/or old stains

3:1 Moderate stains and general cleaning

5:1 Mild or new stains, mild to moderate soiling

Use the same dilution ratio with a pressure washer (900 psi maximum) or automatic floor scrubber. If pressure washer or scrubber is used, hand scrubbing is not necessary. For extremely heavy duty cleaning, use **Wood Cleaner** without dilution.

For best results, use warm water if possible.

CLEANUP: flush with clean water
